**I HEREBY CERTIFY that I am the rightful owner of the craft described on this application; that the address shown is my legal address.**



**Watercraft rack assignments have been made according to the assignment procedures furnished with your application. If there is any confusion about which rack is yours, please contact the Parks and Recreation Department at 952-953-2300.**

**It is imperative that no watercraft be placed prior to May 1, and all watercraft be removed from their rack on or before November 1st.**

## **WATERCRAFT RACK ASSIGNMENT PROCEDURES**

*Racks will be available for watercraft defined as: canoes, kayaks and sailboards. All other craft may be considered for a permit at the City's sole discretion.*

**APPLICANT:** *The Apple Valley Parks and Recreation Department will recognize only the person whose signature appears on the application as being the responsible holder of said rack. At no time may this individual sublease or receive remuneration for the use of their assigned rack without acquiring authorization from the Department.*

**APPLY FOR A WATER CRAFT RACK RENTAL STARTING JANUARY 2.** *All rentals are on a first come first served basis.*

**PERMITS TO BONA FIDE WATERCRAFT OWNERS ONLY:** *No permit shall be issued to anyone except a bona fide watercraft owner who certifies on the form provided that the address stated is her/his legal residence and that the watercraft to be registered is seaworthy. Suitable identification of the watercraft must be made in the application, including color and manufacturer's number, if at all possible. Owner must also furnish Minnesota State watercraft registration number.*

**LIFE PRESERVERS:** *Each craft must carry at least one Coast Guard approved safety device per occupant when in use.*

**STATE LICENSE:** *Watercraft used in the State of Minnesota must be registered with the State.*

**SECURING OF CRAFT:** *It is mandatory that the owner of the craft purchase and maintain their own securing device. This device must be capable of securing BOTH the front and rear of the craft to prevent damage to the craft, city rack and watercraft of others. Failure by the owner of any watercraft to maintain their securing device may result in damages for bodily injury or property damage payable to the City or others or both. The City does not warrant or certify the type or quality of the securing device selected by owner nor the maintenance by owner. The City will not be responsible for the damage to or the theft or disappearance of any watercraft permitted under this application.*

**PLACEMENT OF CRAFT AT BEGINNING OF SEASON:** *No craft shall be placed on racks prior to May 1.*

**REMOVAL OF CRAFT AT SEASON'S END:** *All craft must be removed by November 1 of each year so we can do annual maintenance on the racks. The Parks and Recreation Department reserves the right to ask users to remove their watercraft by October 15, in the event that major repairs need to be done on a given rack. When this occurs, the permit holders will be notified ten days in advance by letter. We will not be able to issue any partial refunds in this case.*

**IT IS IMPERATIVE THAT RACKS BE VACATED BY NOVEMBER 1!** *Please be sure to have your watercraft off of the rack on time so we can keep the racks in good shape. If the Parks and Recreation Department must remove the watercraft, there will be a \$50.00 service charge and \$25 per month storage fee for each month following impoundment.*
