*** LEAGUE NOTES ***

- All matches will be played at the Apple Valley Community Center, 14603 Hayes Rd. **No matches will be played on Nov. 25. Play-offs will be scheduled for Dec. 2nd and Dec. 9th.** Please car-pool as often as possible to alleviate congestion in the parking lot.
- Adult Leagues are created for adult attendance only. If you MUST bring children to the game, a non-playing adult (1 adult per 2 children) must supervise them at all times. Players not adhering to this policy will not be permitted to participate in the game.
- Matches shall consist of 3 games to 25 points, using Rally Scoring (See Playing Rules - #15 for more info). Winning teams MUST report their match score (3-0 or 2-1) on the form provided at the front desk of the Apple Valley Community Center or they will forfeit their wins!**
- In the event of inclement weather team managers should call the AVPR weather hotline after 4:00 p.m. at **952-953-2399, Option #1-Weatherline, then Option #1 – Adult Athletics.** If matches are cancelled, they may be re-scheduled at the end of the regular season, prior to play-offs, time permitting.
- To ensure that the matches start at the scheduled time, a scoreboard horn and timer will be used to signal the start and stop times of each match. The scoreboard on the **south court** of each gym will direct all 3 courts of that gym (north, center, south).
 The first horn will signal the start of the match, which begins the timer counting down to the **55 minute time limit** (regardless of the number of players present). The second horn will signal the end of the match. If the ball is in play when the second horn sounds, play may continue but no additional serves will be allowed. The score at this point will be final (Exception: if the score is tied, ONE rally point serve will be played to break the tie and end the game. The team in control of the serve will serve the rally point.) **PLEASE DO NOT STALL NEAR THE END OF A CLOSE MATCH TO GAIN AN UNFAIR ADVANTAGE!!!**
- Each team will play 9 league matches, followed by the playoffs. A \$30 gift card & League Champion T-shirts will be given to the League Champs; the League Runner-Up will receive a \$20 gift card; and Playoff Champs will receive a \$25 gift card.
Additional dates to put on your TEAMS calendar, Saturday February 4th MID-WINTER FEST APPLE VALLEY'S ONE DAY CO-REC TOURNAMENT. Friday January 6th (the 1st day of Co-rec Friday night Winter league Volleyball.) Make sure to make the registration deadline of the Winter session as it will fill fast!
